

#### **Overview**

Certified Conference Interpreters transfer highly complex, specialised messages from a source language into a target language. They interpret in situations such as speeches and presentations at high-level international exchanges, like international conferences, summits, meetings and negotiations (such as UN summits, bilateral treaty negotiations) across a broad range of domains.

CCIs typically hold a master's degree or higher in conference interpreting (or a combination of extensive work practice and professional development) and a recommended minimum two years' work experience as a conference interpreter in their language combination.

#### Test assessment

Each test is marked by at least two trained NAATI examiners, using an assessment rubric to assess competency in the skills required for each task in the test. Candidates will be given a band level for each skill assessed, with band 1 representing the highest level of performance and band 5 representing the lowest.

This test is delivered online only.

There are separate tests for LOTE into English and English into LOTE certification. Each test will consist of three tasks:



Consecutive interpreting (monologue) of an unseen speech



Simultaneous (booth) interpreting (monologue) of a seen speech



Simultaneous (booth) interpreting (monologue) of an unseen speech

Speeches will be based on reallife speeches at international conferences, summits and negotiations at the level of experts communicating with an expert audience. Each speech will come from a different domain and setting.



# Prerequisite pathways

### Pathway one

- Completed (graduated or eligible to graduate) a NAATI endorsed conference interpreting qualification no more than three years before applying - Master's degree or higher (Australian Qualifications Framework [AQF] Level 9 or comparable).
- Recommended to have at least two years' conference interpreting work experience in same language combination.

### Pathway two

- Completed (graduated or eligible to graduate) a non-NAATI endorsed Conference interpreting qualification - Master's Degree or higher (AQF Level 9 or comparable).
- Met NAATI's standard for ethical competency and intercultural competency. This may include sitting a screening test with NAATI.
- Recommended to have at least two years' conference interpreting work experience in same language combination.

# Pathway three

 Holds Certified Conference Interpreter in another direction or another language pair.

# Pathway four

- Holds AIIC membership.
- Met NAATI's standard for ethical competency. This may include sitting a screening test with NAATI.

### **Pathway five**

- Holds Certified Interpreter in same language.
- Evidence of at least three years' conference interpreting work experience and at least 50 days (35 booth days) in the language combination as a conference interpreter.
- Completed professional development activities to support advanced practice.



# **Recertification requirements**

To support the ongoing professionalism of the industry, any translator or interpreter wishing to maintain a NAATI credential after its three-year validity period must recertify with NAATI.

Recertification means providing evidence of meeting the minimum work practice and professional development criteria set out by NAATI. Recertification is a universal requirement across all practitioners and credential types.
